



# AT CAPITAL DAILY MARKET UPDATE – August 03, 2015

## Overview

The DSEX closed at 4862.6 points, up by 60.5 points. The total transaction was worth BDT 8.1 bn.

Price of 201 issues appreciated whereas 82 issues declined and 36 others remained unchanged.

## Market Commentary:

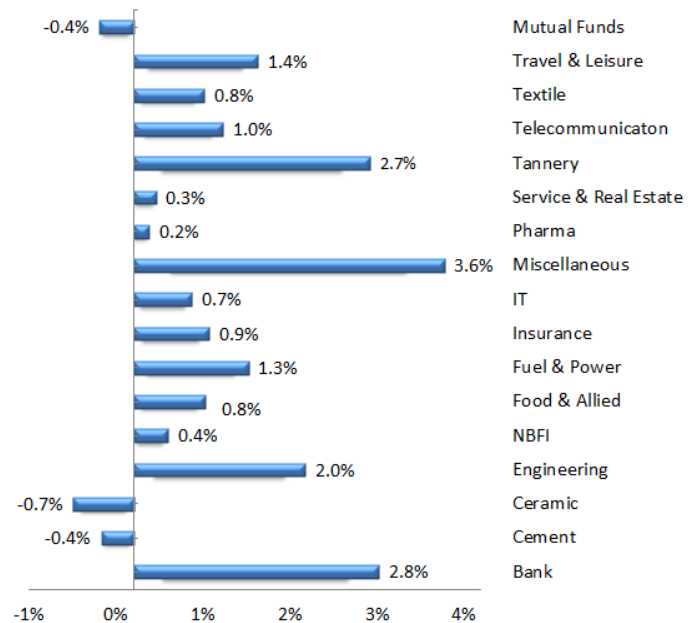
Market extended its rally for another day, amid higher investor confidence. The DSEX opened positive, and continued to gain points at a steady pace throughout the session. The major bourse closed at 4862.6 which is 1.3% higher than the last trading session. Turnover stood at BDT 8.1 bn which is 0.6% higher than the last trading day.

Among the prominent sectors only Engineering and Bank outperformed the market while the rest underperformed. Positive half-yearly earnings declaration by majority of the banks caused a boost in investor confidence that ultimately sustained the rally.

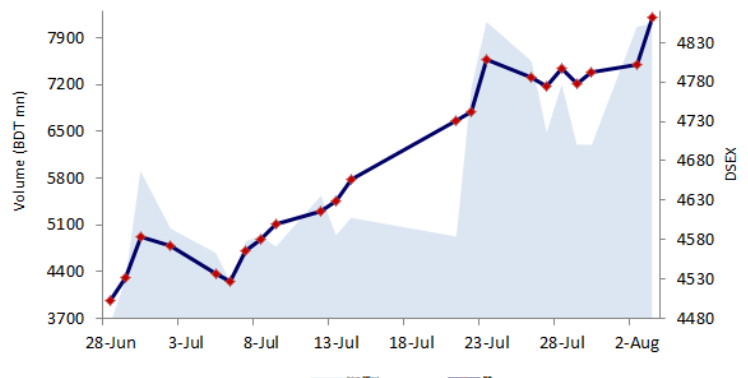
Apollo Ispat Complex (APOLLOISPAT) was the daily turnover leader 3.6% to the total turnover.

## News:

### **MK Anwar gets bail, Aman lands in jail**

Separate Dhaka courts on Sunday sent Bangladesh Nationalist Party joint secretary general Amanullah Aman to jail in a number of cases filed for arson attacks and vandalism during the BNP-led 20-party alliance's blockade and hartal programme.

Ten Chief Metropolitan Magistrate Courts, one Senior Judicial Magistrate Court and one Metropolitan Sessions' Judge Court sent the BNP leader to jail rejecting his bail petitions in 56 cases when he surrendered before the courts in 71 cases in the morning.

Of the 71 cases, Aman was granted bail in seven filed with Paltan, Motijheel, Jatrabari, Khilgaon and Savar police stations while the hearing on eight more cases was deferred as the case documents were not produced before the court.

### **Bank borrowing by govt jumps five times**

The government's borrowing from the banking system increased five times in the first 29 days of the fiscal year from a year earlier on the back of revenue mismatch.

From July 1 to July 29, the government borrowed Tk 9,447 crore from the banking system in contrast to Tk 1,722 crore a year earlier.

Typically, if there is a mismatch between earnings and expenditure, the government meets the gap by borrowing from both the central bank and commercial banks.

### **AIMS 1st , Grameen One trustee decides to convert or redeem MFs by Dec**

The trustee of AIMS First Guaranteed Mutual Fund One and Grameen One : the First Scheme of the Grameen Mutual Fund One has decided to convert or redeem the funds within December 31 this year, DSE web-posts said on Sunday.

Bangladesh General Insurance Company Limited, the trustee of the mutual funds, took the decision as per the mutual fund conversion guidelines following regulatory directive.

In case of conversion of the funds, the process of conversion will be completed within December 31 this year, DSE web-posts said.
